GUIDELINES FOR THE	GUARDIA CIVIL – POLICIA NACIONAL	
APPLICATION OF ROYA DECREE 463/2020 STATE OF ALA	26 (44) (24)(15)(24)	19-03-2020
PEDESTRIANS	1 PERSON, unless accompanying minors, elderly, disabled or vulnerable persons for JUSTIFIED reasons (medical appointment, pharmacy, care, etc.) REQUEST DOCUMENTARY JUSTIFICATION for presence on public highway (tickets, prescriptions, etc.), obtain identification in case of doubt and/or if issuing a fine in the event of repeated or manifestly FALSE or MISLEADING conduct.	
VEHICLES	1 OCCUPANT unless accompanied for a JUSTIFIED reason. The passenger must sit in the REAR SEAT AND BOTH PERSONS MUST WEAR MASKS.	
WORKMEN'S VEHICLES	NO LIMIT ON NUMBER OF PASSENGERS. ALL MUST WEAR MASKS, the employer is liable	
SECOND HOMES	It is NOT permitted to travel to second residences. If the person is already there, it is treated as their habitual residence and the same restrictions apply.	
VISITATION RIGHTS	AUTHORISED. Minors may be taken to the home of the other parent. Safety measures must be applied.	
AGRICULTURE AND LIVESTOCK	PERMITTED journeys to tend to land, livestock, GREENHOUSES, CULTIVATED FIELDS, ETC.	
SELF-EMPLOYED PERSONS	PERMITTED journeys for WORK (plumbers, couriers, electricians, carpenters, salespersons, etc.) With safety measures.	
VEHICLE WORKSHOPS	OPEN TO THE PUBLIC WITH SAFETY MEASURES. For REPAIRS only. The SALE OF PARTS, VEHICLES, ACCESSORIES ETC. IS PROHIBITED	
FAST FOOD	PIZZERIAS, HAMBURGER RESTAURANTS, ETC CLOSED TO THE PUBLIC AND MAY ONLY MAKE HOME DELIVERIES	
READY MEAL VENDORS	OPEN. With the same restrictions as food shops. WITH SAFETY MEASURES.	
SERVICE STATIONS AND AREAS	OPEN. Shops, CAFETERIA and WC CLOSED except for the USE of truck drivers, bus drivers, ambulances, law enforcement officers, etc.	
VALUE STORES, HARDWARE STORES, BAZAARS	CLOSED. Open only for the sale of authorised items: (FOOD, DRINKS, TELEPHONY, HYGIENE PRODUCTS, TOBACCO, PET FOOD, STATIONERY) If their OPENING PERMIT allows and only for the sale of these items. Employees AND CUSTOMERS MUST APPLY SAFETY MEASURES (distance in queues, etc.)	
CONSTRUCTION SANITARYWARE AND CONSTRUCTION MATERIALS	AUTHORISED. WITH SAFETY MEASURES FOR WORKERS AUTHORISED sale to professionals, self-employed and wholesalers. SALE TO THE PUBLIC PROHIBITED	
RESTAURANTS	CLOSED. Home deliveries are authorised under the same conditions as FAST FOOD	
OPEN (with safety measures)	OPTICIANS, ORTHOPAEDIC M	PS, PHARMACIES, MEDICAL CENTRES, IATERIALS, HYGIENE AND CLEANING ID STATIONERY, TOBACCONISTS, GOOD ONLY), DRY CLEANERS,
